

MONDAY, APRIL 25, 1988

The Board of County Commissioners for Tulsa County met at the hour of 2:00 p.m. with the following members present: Lewis Harris, Chairman; John Selph, Member; Melvin C. Rice, Member; Joan Hastings, County Clerk; and Nancy Cooper, Secretary representing the County Clerk's office.

Lewis Harris, Chairman, presiding, called the meeting to order at 2:01 p.m. and the following business was transacted:

Certificate of Recognition was presented to Walter Dirion for his 25 years of service at the Juvenile Bureau.

Certificate of Accreditation was presented to the Board of County Commissioners for meeting the 1987 Standards for Health Services in Jails.

Moved by Rice, seconded by Selph, to approve and authorize execution by Commission, a Resolution expressing its unqualified support for the Oklahoma Turnpike Authority to bring about the construction of a four lane turnpike to
