APPLICATION OF THE BOARD OF COUNTY COMMISSIONERS  
OF TULSA COUNTY, OKLAHOMA, FOR ADDITIONAL AND  
SUPPLEMENTAL APPROPRIATIONS FOR THE FISCAL YEAR  
ENDING JUNE 30th, 1936.

TO THE EXCISE BOARD OF TULSA COUNTY, OKLAHOMA:

Gentlemen:

In pursuance of the provisions of Section 12680, Oklahoma Statutes of 1931, application is hereby made for additional and supplemental appropriations with which to meet the legal and ordinary expenses of Tulsa County, Oklahoma, for the remainder of the fiscal year ending June 30th, 1936, and for an order cancelling certain appropriations or parts hereof heretofore made for said year.

In support thereof, we do hereby certify:

FIRST: That certain appropriations heretofore made are inadequate to properly maintain the GENERAL FUND OF Tulsa County, Oklahoma, for the current fiscal year, and that the public welfare and needs of said County are such as to require for the remainder of said year, for legal and ordinary expenses, the additional appropriations as listed and set forth by purposes and amounts in Exhibit "A" attached, and made a part hereof.

SECOND: That the Financial Statement hereto attached and marked Exhibit "B" shows as of the close of the month preceeding the filing hereof the true and correct condition of the GENERAL FUND of said municipality, and that the surplus of \$6,886.58 thereof shown is available for additional appropriations.

THIRD: That the appropriations listed in Exhibit "C" hereof aggregating \$8,594.48 are for purposes less urgent and imperative than the additional needs herein requested.

WHEREFORE, request is hereby made that the surplus existing in the GENERAL FUND for the fiscal year 1930-31 and back in the amount of \$6,886.58 and the revenue released by said cancellations in the amount of \$8,594.48 and a total amount of \$15,481.06 be appropriated for the several additional and supplemental purposes as set forth in Exhibit "A" hereof.

WE FURTHER CERTIFY, that the aggregate amount of said proposed additional and supplemental appropriations is not in excess of the income and revenue provided and accumulated for the current years.
