MANAGEMENT CONFERENCE

Thursday, May 14, 1987

The Board of County Commissioners met at the hour of 9:30 a.m., with the following members present: Melvin C. Rice, Chairman; Lewis Harris, John Selph, Members. Members absent: none. Others present: Clayton Edwards; Wayne Carr; George Phillips; Ron Mize; Jim Crawley; Mike Kimbrell; Miles Saunders; Janice Lintelman.

Melvin C. Rice, Chairman, presiding, called the meeting to order at 9:05 a.m., and the following business was transacted:

Staffing of the Jenks Golf Course, as outlined in a memo from Mr. Phillips, was discussed. Motion by Selph, seconded by Harris, to direct Mr. Phillips to continue with the necessary action for organization of staff for the Jenks Golf Course; and to direct the Chairman to execute a letter of intent to Jerry Jones concerning his contract as Director of the new golf course. Upon roll call, Harris, yes; Selph, yes; Rice, yes. Motion carried.

Mr. Phillips also asked the Board to consider adding one car to the Park Department's fleet at the time the new course is opened. The Chairman indicated the request would be considered at that time.
