The following Resolution was duly approved and passed by the Board.

#### R E S O L U T I O N .

A Resolution granting to the Oklahoma Union Railway Company, its successors and assigns, the right to construct, maintain and operate through, over and along certain streets in the Village of Walters, Oklahoma, and granting an easement in said streets for the purpose.

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF TULSA COUNTY, OKLAHOMA

Section 1. That the Oklahoma Union Railway Company is hereby granted the right to construct, maintain, and operate a line of railroad, and all necessary appurtenances thereto, through, over and along the following described streets, to-wit:

Over and along Edna Avenue in the Village of Walters, Tulsa County, Oklahoma, for m the Southerly intersection of Edna Avenue with Fuller Street in a Southerly direction along said Edna Avenue to the South end thereof and across the South end of Walter Avenue, the same being also in the Village of Walters, Tulsa County, Oklahoma.

Section 2. That the Oklahoma Union Railway Company, its successors and assigns, is hereby granted an easement in those portions of Edna Avenue and Walter Avenue as above descrined in order to construct the said railroad and its appurtenances.
