Pursuant to recess heretofore taken, the Board of County Commissioners reconvened at the hour of 2:00 o'clock P. M. with all members present: J. B. Gray, Chairman; Curtis Greer and Claude W. Bailey. Members: William P. Gable, Jr., County Clerk.

J. B. Gray, Chairman, presiding, the following business was transacted.

Motion made by Commissioner Greer, seconded by Commissioner Gray, that the Depository Agreement by and between the First National Bank of Broken Arrow, Oklahoma, and the Board of County Commissioners in the amount of \$30,000.00, be and the same is hereby approved. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

Motion made by Commissioner Greer, that the Board of County Commissioners permit a group of Tulsa physicians to use the Tulsa County Clinic, at no expense to the County, to conduct a series of weekly clinics for crippled children and other patients qualified by the Oklahoma Crippled Childrens Commission, who are not able to pay the costs of medical care. Mr. Bailey: "I second that motion, providing the physicians conducting the clinics for crippled children arrange with the Tulsa County Clinic to use the Clinic only when it is convenient." Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

Motion made by Commissioner Greer, seconded by Commissioner Bailey, that the report filed by W. K. Gray, Secretary, of the Tulsa State Fair, for the year ending December 31, 1946, be and the same is hereby accepted and filed. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

Motion made by Commissioner Gray, seconded by Commissioner Greer, that the National Surety Corporation Bond No. 796598 in the amount of \$1,000.00 filed by H. H. Miller, Constable, in District 4 Division 4, filed on October 5, 1945, be and the same is hereby canceled. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

Motion made by Commissioner Greer, seconded by Commissioner Gray, that upon the recommendation of Garrett Newman, County Assessor and Hugh Webster, Assistant County Attorney, the corrected affidavit of Erroneous Assessment in favor of R. F. Newman, covering assessment on real estate for the year 1946, in the amount of \$51.52, be and the same is hereby approved, and the County Clerk is hereby instructed to issue a corrected Certificate of Error covering same. Also that the Cash Voucher Claim in favor of Louise Ennis, Tulsa, in the amount of \$57.90 covering refund of tax paid by purchase of tax sale certificates Nos. 1088, 1089 and 1090, 1943 sale of 1942 tax covering lots 22 to 24 in Block 48 West Tulsa, be and the same is hereby approved. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.
