- 1. To complete the audit of Frances Harvey, former Court Clerk of said County.
- 2. To audit the records, in detail in the office of the Treasurer of said County during the encumbency of Wayne L.Dickey, and which audit shall include the acts and records of said Treasurer and W.M.Gulager, Tax Ferett, in relation, concerning and connected with property omitted from the Tax Rolls of said County, and placed upon the rolls thereof under and by virtue of Article 13, of Volume 2, Compiled Statutes of Oklahoma, 1921.
- 3. To audit all suit now pending, or hereafter filed, in any Court involving taxes paid under protest.
- 4. To audit and examine all claims filed against said County, and the several Townships therein, before presented to this Board and recommend proper action thereon.
- 5. To audit and examine all claims and demands for refunds of any character against said County and the several Townships therein before being presented to this Board and recommend proper action thereon.
- to the County Clerk before the payment thereof.
- 7. To audit and examine all officers reports before presented for approval to this Board and make proper recommendations thereon.
- 8. To provide a system and install the same innthe purchasing of supplies, equipment, furniture, machinery, tools records and other articles to be used by the various officers of said County and the Several Townships therein.
- 9. To provide a form of monthly salary pay roll claim for each Department of the County and the Several Townships therein.
- 10. To examine and inspect all applications for Erroneous Assessments and recommend to this Board proper action thereon.
- . 11. To audit and examine all Budgets of the several Municipalities in said County and report thereon to the Excise Board of said County.
- 12. . To prepare tax levies for the fiscal year of 1923-1924 and report same to Excise Board for approval.
