Claude W. Bailey, Chairman, presiding, the following official business was transacted:

Motion made by Commissioner Evans, seconded by Commissioner Couch, and unanimously carried, that hearing on the matter of the Application of John E. Archer for the opening of a Roadway, was set for hearing before the Board of County Commissioners on October 25, 1948, at the hour of 10:00 O'clock A. M., and the Clerk is hereby authorized and directed to notify the property owner, Mrs. M. E. Morrison, of the date of hearing.

Motion made by Commissioner Evans, seconded by Commissioner Couch, and unanimously carried, that Dr. Irvin D. Palm be, and he is hereby appointed as Assistant County Physician (Negro) temporarily, replacing Dr. Perry, as of October 1, 1948.

Motion made by Commissioner Evans, seconded by Commissioner Couch, and unanimously carried, that \$250.00 be and the same is hereby accepted from the Wilcox Oil Company, covering accident to County Truck on Ranch Creek Bridge, and Commissioner Evans is hereby authorized to sign Release relieving the Wilcox Oil Company from further liability, upon the recommendation of Hugh Webster, Assistant County Attorney.

Motion made by Commissioner Evans, seconded by Commissioner Bailey, and unanimously carried, that the following Resolution be, and the same is hereby adopted:

RESOLUTION

WHEREAS, there has been established a Federal Aid Secondary Road System for the County of Tulsa, State of Oklahoma, and approved by the Federal Works Agency, Public Roads Administration, and the State Highway Commissioner:

AND WHEREAS, it is deemed desirable now that the system heretofore established be enlarged and added to and corrected to include Sheridan Road from Admiral Place to 11th Street.

NOW, THEREFORE, be it resolved that the Department of Highways of the State of Oklahoma, is hereby requested to revise the Secondary System heretofore established, by adding the Following Roads, to-wit:

By Resolution of the Board of County Commissioners of Tulsa County, Oklahoma, adopted the 13th day of July, 1948, desires now to amend their resolution dated the 13th day of September, 1948, eliminating the resolution of this date and substituting this resolution which will include Sheridan Road from Admiral Place to 11th Street.

REASONS

It is proposed in the near future to build a pedestrian underpass across Admiral Place along or in the vicinity of Sheridan Road to provide protection for school children and adults crossing this heavy traffic highway. It is also desirable that the mile of highway from Admiral Place to 11th Street be included in the Secondary Road System for eventual remodeling.
