Coming on for a hearing is Zoning Application CZ-165, W. Knigge, Applicant, tract located North of NW/c of East 56th St. No. & North Peoria Avenue. Harris stated \$50. publication fee paid and hearing would proceed. Irving Frank, INCOG, was present and stated this application covers two 2-lot tracts and that the planning staff recommends CG zoning on the North two and CS on the South two. Harris asked if anyone present to speak for or against the application. Kenneth Ellison, Attorney, was present to represent the applicant. He stated the applicant would accept the staff's recommendation but would prefer to have CG on both tracts. There were no protestants to be heard but Mrs. Johnson, homeowner on the lot between these two tracts, had written a letter expressing her concern about increased activity in the area. He feels that the applicant's intended use of the property (mobile home parts and supply business) would cause less activity than the rental use of the property at this time.
