And, it appears from said canvass that a majority of all the votes cast are for "Water Improvement District No. One "YES", IT IS THEREFORE ORDERED: That the territory within the boundaries of said proposed Water Improvement District No. One, described as follows:

Beginning on the 96th. Meridian at the Southwest Corner of Section 23, Township 20 N. R., 1e E., Tulsa County, Oklahoma and running thence East along the Section line between said Section 23 on the North and Section 26 on the South and Section 24 on the North and Section 25 on the South in said T. 20, N. R. 12 E and continuing East along the projection of said Section line between Sec. 19 on the North and Sec. 30 on the South to the S.E. Corner of said Section 19 in T. 20 N R. 13 E., Tulsa County, Oklahoma, thence North along the Section line dividing between Section 19 on the West and Section 20 on the East in said T. 20 N R. 13 E., Tulsa County, Oklahoma, and following the projection of said Section Line North to the S.E. Corner of Section 7, T. 21., N.R. 13 E., thence West along the Section Line dividing said Section 7 on the North and Section 18 on the South in T. 21 N., R. 13 E., Tulsa County, Oklahoma, to the S.W. Corner of said Section 7, thence North along the Section line dividing said Section 7, T. 21 N. R. 13 E., on the East and Section 12 T. 21 N. R. 12 E., on the West and following the projection of said Section Line North to the N.E. Corner of Section 24, T. 22 N.R. 13 E. thence West along the Section Line dividing Section 13 on the North and said Section 24 on the South and the projection of said Section Line to the 96th.
