## RESOLUTION

WHEREAS, formthe purpose of constructing a highway through and across a certain parcel of land in Section Thirty One (31), Township Nineteen (19) North, Range Twelve (12) East, Tulsa County Oklahoma, it is necessary to acquire an EASEMENT across said parcel of land more particularly described as follows:

NOW, THEREFORE, BE IT RESOLVED, that the County Attorney, in the name of this Board, for and on behalf thereof be and he is hereby instructed to institute condemnation proceedings in the District Court of this County for the purpose of condemning said above described parcel of land for right of way for highway purposes.

AND, BE IT FURTHER RESOLVED, That this Resolution shall be in lieu of a resolution passed by this Board on December 5, 1932, aithorizing the County Attorney to institute condemnation proceedings against a parcel of land in Section 31, T 19 N., R 12 E. owned by FLORENCE C WHITTINGTON, EMILY C POTTER and J J CULBERTSON, Jr.
