RESOLUTION

WHEREAS, Robert E. Adams has filed affidavit of erroneous assessment with the Board of County Commissioners of Tulsa County, Oklahoma, seeking an order directing the County Assessor of Tulsa County, Oklahoma, and the County Treasurer of Tulsa County, Oklahoma, to cancel and strike from the assessment rolls and the tax rolls taxes assessed and levied against the following described property:

> The NE/4 of the NE/4 of Section 9, Township 19 North, Range 14 East, Tulsa County, Oklahoma,

otherwise described:

Blocks 1,2,5 and 6, of Eleventh Street Acres, Tulsa County, Oklahoma

for the years 1936, 1937, 1938, 1939, 1940 and 1941, or that the Board of County Commissioners issue to affiant a Certificate of Error cancelling the taxes on said property for said years for the reason that said property for said years was owned by a restricted full-blood Creek Indian and as such was not subject to taxation for said years; and

WHEREAS, the Affidavit of Erroneous Assessment is found to be in due form and upon investigation made by said Board and from evidence of witnesses sworn and examined before said Board on this 22nd day of March, 1943, this Board finds the allegations in said Affdavit of Erroneous assessment are true and that the property was erroneously assessed for taxation for said years, and that said property was not subject to assessment and taxation for said years.

NOW, THEREFORE, BE IT RESOLVED that the aforesaid property for said years be ordered stricken from the tax rolls and that a Certificate of Error be issued as provided by law cancelling the assessment of said property and all ad valorem taxes thereon for the years 1936-, 1937, 1938, 1939, 1940 and 1941; and the County Treasurer is hereby authorized to accept this certificate as a payment of cash for the amount of taxes assessed against said property for said years.
