Dick had questions regarding the pupil membership figures. The State Department of Education shows 92,195 students enrolled in schools as of September, 1990. The 1990 federal census shows a 20,000 student discrepancy. Dick asked Wilson to investigate this further. Selph suggested that Wilson's office determine how many students attend Tulsa schools yet live outside Tulsa County.

Moved by Selph, seconded by Dick, to approve the revised language of a section of TCP #108, Educational Assistance Program, submitted by Edwards. Upon roll call, Selph, yes; Dick, yes; Harris, yes. Motion carried.

Herb Reed was present to discuss the letter from the Mayor of Sperry asking permission for those persons recommended by the Sperry Municipal Courts for performance of community service be referred to the Tulsa County Work Program. Chairman suggested Reed work with Edwards to establish a reasonable charge for the County to perform this service. Chairman asked this subject to be placed on the next management conference agenda.

Linda Johnston was present to discuss Edwards' memo dated 10-10-91 regarding the X-Ray Service Recommendation. The Board agreed to the following:

1. Discontinue in-house x-ray service. This decision would require the Sheriff's Department, Juvenile Bureau, and Social Services Divisions to arrange and fund their own x-ray services. Edwards to notify divisions involved.
2. Edwards is to work with Linda Johnston and Purchasing to develop RFP's for x-ray services for Tulsa County.
3. At the appropriate time, Social Services will seek approval to properly dispose of its x-ray equipment.

Terry Tallent was present to discuss his memo dated 10-4-91 regarding Telephone Job Line. Moved by Selph, seconded by Dick, to approve the request as outlined in Tallent's memo. Upon roll call, Selph, yes; Dick, yes; Harris, yes. Motion carried.

Moved by Selph, seconded by Dick, to approve the following individual nominees and member organizations to the Greater Tulsa Area Indian Affairs Commission:

1. Ms. Okema Randall, term ending December 31, 1994

- (As their terms expire, appointments will be made for three-year periods.)


