Motion was made by W.L.North, seconded by Ed W.Hedgecock, that upon recommendation of Dan W.Patton, County Engineer, that the Section Lines between Sections 3 and 4, Twp.18, Range 13 E., and Sections 33 and 34, T. 18, R. 13, E. be ordered opened and that the property owners bennotified to move fences back. Motion carried.

Motion was made by W.L.North, seconded by J.S.Shaver, that the work of County Scavenger be awarded to three parties, namely, T.D.Wright, C.J.McEwen and Louis Johnson. after the filing of a sufficient bond in the sum of \$500.00. The territory awarded each is herewith set out:

T.D.Wright: That part of the County of Tulsa, adjacent to the City of Tulsa, save and except that part lying between the City of Tulsa and Sand Springs, also saving and excepting that part of the colored Section of said County lying outside and immediately adjacent to the city of Tulsa.

C.J.McEwen: All and singular the territory lying along the Sand Springs Road between Fulsa on the North and the corporate limits of the City of Sand Springs on the East.

Louis Johnson: That part of the County of Tulsa, adjacent to the City of Tulsa, save and except that part and all and singular that part of the colored section of Tulsa lying outside and adjacent to the corporate limits of the City of Tulsa.

The vote on the motion was unanimously in the affirmative, and declared carried.

Motion was made by W.L.North, seconded by J.S.Shaver, approving the appointment

of Alma Dort, as Assistant County Superintendent of Schools, at a salary of \$200.00 per

month. Said appointment is recommended by A.G.Bowles, County Suprintendent. Motion carried.

Motion was made by W.L.North, approving the County Engineer's estimate and forms of proposal for letting on the 17th. day of September, 1923. Motion was duly seconded by J.S'Shaver and declared carried.

Orders were signed for the admittance of the following patients into various State Sanatoriums, as herewith shown: Frank Myton into Tubercular Sanatorium at Talihina, Oklahoma and Fred Peason into the Tubercular Sanatorium at Boley, Oklahoma.

Motion was made by W.L.North, seconded by JIS.Shaver, that the award for the paving and otherwise improving that past of Section "WI beginning at Sta.0/15 and extending to Station 127/30 Tulsa County State Highway, becand the same is hereby made to Burke-Gibbs Company, they being the best bidders therefor.
