C O N T R A C T

THIS CONTRACT, Made and entered into at Tulsa, Oklahoma, by and between SILLS FUNERAL HOME of Vinita, Oklahoma, hereafter designated and referred to herein as the party of the first part, and THE BOARD OF COUNTY COMMISSIONERS OF TULSA COUNTY, OKLAOMA hereinafter designated and referred to as party of the second part.

WITNESSETH: It is hereby agreed that in the event of the death of any person or persons now committed or who may hereafter be committed from the County of Tulsa, State of Oklahoma, to Eastern Oklahoma Hospital for Insane at Vinita, Oklahoma, the corpse of such person or persons shall forthwith and immediately be delivered and turned over to said party of the first part, at said insitution, for undertaking and mortician service; and, that of such services and supplies shall be done, furnished and performed by said party of the first part, with the cost of One Cent Per pauper, and undertaking work will be done by Licensed Embalmer of the State of Oklahoma in a skillful manner.

IT IS FURTHER AGREED, By and between the parties hereto that this Contract shall and will be in full force and effect for and during the period of from June 6th. 1933 to June 6, 1935 and said Contract shall and will be executed and said form shall be transmitted to the Superintendent of Eastern Oklahoma Hospital for the Insane at Vinita, Oklahoma, and that the copy so transmitted to said Superintendent shall and will be his authority for the delivery of bodies herein provided for, to said party of the first part.
