O R D E R

WHEREAS, the Treasurer of Tulsa County, Oklahoma, has filed and presented to the Board of County Commissioners of the County of Tulsa, State of Oklahoma, an application for the issuance to Wade C. and Clark H. Whiteside of a deed conveying to him for a consideration of Twenty-Five and No/100 dollars (\$25.00) the following described lot:

Lot 4, Blk 5, Bozarth Acres Addition

AND WHEREAS, the sale of said lot by the County Treasurer was made pursuant to Section 2 of H. B. 121 of the Compiled Statutes of Oklahoma of 1935, and amendments thereto, whereby the County Treasurer is authorized to sell lands and lots purchased for the County by him at tax resale, and

WHEREAS, due notice has been given and published by the County Treasurer in the Tulsa Daily Legal News, the official paper of the County of Tulsa, that said County Treasurer would on this date apply to the Board of County Commissioners for an order approving said sale, and directing the issuance of deed therefor, and

WHEREAS, pursuant to such notice, hearing on such sale has been had by the Board of County Commissioners on January 20th, 1936, the date specified in said notice, but said hearing was continued until February 17th, 1936, at which time Wade C. and Clark H. Whiteside having appeared and having offered a higher price, to-wit: \$50.00 for the purchase of said lot, that the \$25.00 offered by the original bidder, and the County of Tulsa has no need for said lots for any purpose required and provided by law whatsoever.

NOW, THEREFORE, the Board of County Commissioners of the County of Tulsa, State of Oklahoma, in regular session assembled and pursuant to the aforesaid statutes of the State of Oklahoma, hereby approve the sale of said property so made by the County Treasurer to Wade C. and Clark H. Whiteside for a consideration of \$50.00, and it is hereby ordered that the Chairman of the Board of County Commissioners execute to Wade C. and Clark H. Whiteside a deed conveying to them all the right, title and interest of the County of Tulsa, State of Oklahoma, in and to said property and the County Clerk of Tulsa County is hereby directed to attest with his signature the seal of his office.

Motion by Commissioner Gray, seconded by Commissioner Hopkins, that the complaint of erroneous assessment of The Western and Southern Life Insurance Company for ad valorem taxes against the North Fifty (50) feet of Lot Five (5) and all of Lot Six (6) in Block 190 in the Original Town, now City of Tulsa, Tulsa County, Oklahoma, be and the same is hereby disallowed. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

The Petition of the Granite Savings Bank & Trust Company for correction of erroneous assessments on Lot 4, Block 171 for ad valorem taxes for the years 1930-1931 and 1932, and Lot 5, Block 40 for the years 1929 and 1932, the North Sixty Feet of Lot 6, Block 184 for the years 1931 and 1932, came on for hearing on its merits in accordance with order of the court remanding said cause to the Board of County Commissioners for further determination. It was moved by Commissioner Gray, seconded by Commissioner Hopkins, that the Petition be and the same is hereby denied. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.
