R E S O L U T I O N

WHEREAS, there is pending before the State Industrial Commission of Oklahoma, cause B-47292, a claim filed by N. Hoffarth against the Board of County Commissioners of Tulsa County, Oklahoma, for compensation by virtue of personal injuries sustained by said claimant on the 20th day of October, 1942, while in the employ of Tulsa County, Oklahoma, which claim falls within the purview of the Workmen's Compensation Act of the State of Oklahoma, and

WHEREAS, at a regular hearing upon said claim the State Industrial Commission found that said injury was compensable and ordered the Board of County Commissioners of Tulsa County, Oklahoma, to compensate said claimant therefor on the basis of temporary total disability. Total sum of \$390.00 as temporary total disability compensation has accrued since the 20th day of October, 1942, (less the five day waiting period) up to and including March 26th, 1943, at the rate of \$18.00 per week, upon which sum the respondent has heretofore paid the sum of \$318.00 by virtue of said order; the balance in the sum of \$72.00 to be paid as per claim for the weeks ending March 5, 12, 19 and 26, 1943, respectively, and

WHEREAS, claimant's temporary total disability has ceased (the healing period has not ended), and said matter is yet pending before said State Industrial Commission to determine the extent of claimant's permanent partial disability, which has been determined by the attending physician to be ten per cent, which thereby entitles claimant to compensation therefor in the amount of \$1,000.00, if and when the State Industrial Commission enters an order thereon.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Tulsa County, Oklahoma, duly assembled in an open and regular meeting, as provided by law, that the County Attorney of Tulsa County, Oklahoma, be and he is hereby authorized and directed to appear on behalf of this respondent before the State Industrial Commission and join with claimant in a joint petition for the purpose of having the State Industrial Commission determine on said joint petition the extent of claimant's permanent partial disability, and fixing compensation therefor.
