The following Resolution was introduced by Commissioner Hedgecock, who moved its adoption. The motion to adopt the Resolution was seconded by Commissioner Dickey and the Chairman ordered the same read:

RESOLUTION

A RESOLUTION PROVIDING FOR THE ISSUANCE OF "TULSA COUNTY, OKLAHOMA, FREE FAIR BONDS" IN THE SUM OF FIVE HUNDRED THOUSAND DOLLARS (\$500,000.00) AUTHORIZED AT AN ELECTION DULY CALLED AND HELD FOR SUCH PURPOSE, PRE* SCRIBING THE FORM AND NUMBER OF BONDS, PROVIDING FOR THE LEVY AND COLLECTION OF AN ANNUAL TAX FOR THE PAYMENT OF THE PRINCIPAL AND INTEREST ON SAME, FIXING OTHER DETAILS OF SAID ISSUE AND DECLARING AN EMERGENCY.

WHEREAS, on the 4th. day of November, 1930, pursuant to a notice duly given, an election was held in and throughout Tulsa County, Oklahoma, for the purpose of submitting to the qualified electors the question of the issuance of its negotiable coupon bonds in the aggregate sum of Five Hundred Thousad Dollars (\$500,000.00) for the phrpose of providing funds to purchase lands, improve the same and to construct buildings thereon for free fair purposes, the same to be owned and controlled by said Tulsa County, Oklahoma, as provided by Senate Bill No. 46, Acts of the 12th. Legislature, Chapter 26, Session Laws of the year 1929, and as provided by the Constitution and Statutes of the State of Oklahoma, complementary, supplementary and enacted pursuant thereto, said issue to be known as "Tulsa County, Oklahoma, Free Fair Bonds of 1930, and

WHEREAS, AS shown by the canvass of the returns of the County Election Board there was cast at said election, on said proposition, by the qualified electors of said County, 29,630 votes, of which 17,858 were in favor of and 11,772 were against the issue of said bonds, and

WHEREAS, a lawful majority consisting of three-fifths or more of the voters of said County voting thereon at said election cast their votes for said proposition, and the proposition for the issue of said bonds carried, the issuance thereof has been duly authorized.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF TULSA COUNTY. OKLAHOMA.

Section 1. There are hereby ordered and directed to be issued the negotiable coupon bonds of said Tulsa C unty, Oklahoma, in accordance with the form herein set out in the aggregate amount of Five Hundred Thousand Dollars (\$500,000.00) which bonds shall be designated as "Tulsa C unty, Oklahoma, Free Fair Bonds of 1930" and which shall be Five Hundred (500) in number, and numbered One (1) to Five Hundred (500) both inclusive, and of the denomination of One Thousand Dollars (\$1,000.00) each, and shall be dated January 15th.1931, and become due and payable serially as follows:
