That each of said bonds shall be signed by the Vhairman of the Board of County Commissioners and the corporate seal of said County affixed thereto and attested by the County Clerk of said County; and ech of said interest coupons shall be executed by the lithographed facsimile signatures of said Chairman and County Clerk, and said officers are hereby authorized and directed to cause said bonds and interest coupons to be prepared and to execute the same for and on behalf of said County; have the same registered by the County Treasurer, certified to by the County Clerk and County Attorney, and presented to the fittorney General, Ex-officio Bond Commissioners, together with a certified transcript of all proceedings in connection with their issue, for his approval and indorsement, and thereafter to be delivered to the purchaser, upon the payment of the purchase price therefor.
