Minutes of the meeting of the Board of County Commissioners of Tulsa County, Oklahoma, held on the 22nd day of November, 1917, at the office of the County Clerk, the same being an adjourned session.

The Board met to canvass the returns of the County Road Bond election held on the 20th day of November 1917, on the question of issuing the bonds of Tulsa County, in the amount of \$1,750,000.00 and to take action on the bond issue.

The Board hereby declares of record that the above named election was conducted by the officers designated by the Chairman of the Board, with all vacancies filled according to law, in all respects as required by law; and

Now after carefully canvassing the returns of the elction the Board finds that
That the total number of ballots cast by the qualified electors of the County was
Total vote for the bonds was (cast) 3809
Total vote against the bonds was (cast) 3239
Total number of mutilated ballots cast was (cast) 566
4

The Board finds that all voting places were property opened and the election legally conducted in each precinct, excepting in precinct No 1, in Willow Springs Township, where no election was held because the election officers dis not appear for the purpose of conducting the same, excepting E.L. Arnold, Judge, and he was unable to hold said election bacause no substitutes could be obtained; that the total number of registered voters in said precinct is 99, and this Board does now cast 99 votes ggainst said bonds, making a total vote against the bonds, 665.

That a lawful majority consisting of three-fifths or more of the voters thereof voting at said election cast their ballots for the bond and that the proposition for the bonds carried.

The Board finds that from proof that the proclamation of said Election was duly published for more than four consecutive weeks prior to the date of said election in a weekly newspaper published and of general circulation in said County according to law, that said election was conducted by ballot in the form prescribed by law; that the polls were opened at seven o'clock A.M. and closed at six o'clock P.M. on said date, excepting in the City of Tulsa, where the polls were opened at six o'clock A.M. and closed at seven o'clock B.M. on said date, ss shown in the returns of said election.

Thereupon the following resolution was regularly moved, seconded and voted upon by Ayes and Nays and adopted by a vote of three Aues and no Nays.
