The Board of County Commissioners met in a regularly adjourned session with all members present, Ed W Hedgecock, Chairman, W L North and Wm.O. Bohnefeld, Members.

Reading of the minutes of the previous meeting was dispensed with and there being no objections to the same, they were ordered to stand approved.

Chairman Hedgecock presiding, the following business was transacted.

The matter of the application of W D Barry, Jr. and Exchange Trust Company as Trustees and William D Barry Jr. for a correction of errors and of erroneous assessment of Real Estate for taxation was presented, and upon motion of Mr. North, duly seconded by Mr. Bohnefeld, the Board refuses to entertain the said application upon the grounds that they are without jurisdiction. Motion carried.

Pursuant to order heretofore made by the Board, the matter of the awarding Contracts on proposals submitted to the Board under date of June 5th.1933 was presented and upon motion of Mr.Bohnefeld Proposal No.1, was awarded to EVANS AND MEAD upon their bid of \$55,622.06. Mr.Bohnefeld's motion is supplemented by Mr.North, who instructs the County Clerk to hold the two next lowest Bids until such time as the said EVANS AND MEAD comply with all requirements as made by the Board of County Commissioners. Motion was duly seconded and upon roll call, all Members voting in the affirmative, was, by the Chairman declared carried.
