RESOLUTION.

WHEREAS, during the fiscal year ending June 30th, 1921, this Board awarded a contract to J. H. Shallenbarger for the purpose of cleaning out certain ditches in Drainage District No. 1 of Tulsa County,

AND WHEREAS, a special levy was made for such purposes by the Excise Board of Tulsa County for such fiscal year and the funds for such work have been available and now are available,

AND WHEREAS, the said J. H. Shallenbarger has not entered into contract with the said Board in writing for such work, and has now shown a disposition to carry out the intentions of the award, and the said ditches urgently require attention without further delay,

NOW, THEREFORE, in consideration of the above IT IS HEREBY RESOLVED, by the Board of Commissioners of Tulsa County that all rights in and to said contract have ceased to exist on the part of said J. H. Shallenbarger, said J. H. Shallenbarger is hereby recinded and a cancellation made thereof,

AND BE IT FURTHER RESOLVED that the County Engineer be instructed to take such steps as are necessary to clean out the said ditches insofar as the funds may be sufficient to accomplish the purpose, either by contracting the same, or by day labor, and that the County Clerk be authorized to notify the said J. H. Shallenbarger of the action of this Board.
