

Tulsa Okla. Feb. 24" 1909.

Pursuant to previous agreement the County Commissioners of Tulsa County met in County Clerk's office at 9 A.M. present W.S. North, C.H. Cleveland & Geo McFecham. The minutes of meeting of January 7, 1909 was read and accepted. On motion of Board the County Judge was authorized to employ an additional clerk at a salary not to exceed Sixty Two Dollars per month. On motion W.S. North was elected chairman of Board of County Commissioners for the year 1909. On motion of Board the County Clerk was authorized to advertise for bids for the County Printing for the year 1909 the same to be restricted to papers having a sworn circulation of not less than 2500. Bids to be on file in County Clerk's office not later than April 1, 1909 and same to be opened at the regular session of Board on April 5, 1909 at 10 A.M. The Board reserves the right to reject any or all bids. The Clerk was instructed to proceed to open bids on file for the erection of thirteen bridges according to plans and specifications now on file. The Central States Bridge Co. of Indianapolis Indiana being the lowest bidder was awarded the contract at a price of \$13256⁰⁰ all bids for Fills were rejected on motion of Board. On motion of Board the County Commissioners instructed the County Clerk to prepare notices that the Board will take up all grievances as to the taxation of property at their regular quarterly meeting in April 1909.

It appearing upon the Assessor's Rolls that J. W. Crutchfield Personal Property was assessed for One Thousand Dollars more than listed the County Commissioners hereby authorize the County Clerk to certify error to the County Treasurer to the amount of \$20²⁵ on the Tax Rolls of Town of Broken Arrow. The resignation of E. L. Muddleston, Trustee Wekiwa was read and on motion was accepted. The Petition of O. W. Stottlemire for the appointment as Trustee was presented and on motion of Board O. W. Stottlemire was appointed to said office. The resignation of Wm. Boswell, clerk of Wekiwa Twp was read and on motion same was accepted. The Bonds of The Merchants & Farmers Bank of Bixby Okla & The Bond of The American Banking Co of Tulsa was on motion passed for the present and each Bank was instructed to place seal on Bonds. On motion of Board County Clerk was instructed to notify County Treasurer to use money available in Sinking & Interest funds to apply on Coupons of County's Bonds and liquidate same until all coupons that are due are taken up. On motion County Clerk was instructed to write warrant for Ten Dollars made payable to the clerk of the Supreme Court for Fee in appeal case of W. W. Stuckey of District Court. In the matter of The Road Petition of d. E. Stearns et al. a favorable report was made upon same and the following Viewers were appointed. E. L. Eoley, John Kramer & Wm. McNulty to meet The County Surveyor on the 23rd day of March 1909 at 10 A.M. In order by The Board of County Commissioners.
