

INADVERTENTLY OMITTED FROM THE MEETING OF DECEMBER 29TH.1930.

R E S O L U T I O N .

The Petition of the Public Service Company of Oklahmma, was presented and after due deliberation the following Order was made:

O R D E R

WHEREAS, the Public Service Company of Oklahoma has requested the Board of County Commissioners to grant permission to said Company to establish a pole line carrying cross arms and electric wires for the transmission of electric current along certain highways in the County of Tulsa, State of Oklahoma, and more particularly described as follows:

Along County Road running South, bordering the Town of Broken Arrow on the West and Sections 10 and 15 on the East, in Boles Township, as shown in attached Exhibit "A".

WHEREAS, it appears that said petition should be granted.

NOW, THEREFORE, BE IT RESOLVED, that permission be, and the same is hereby given the Public Service Company of Oklahoma to construct, operate and maintain a pole line with cross arms and wires for the transmission of electric current on the public highways above described.

BE IT FURTHER RESOLVED, that said pole line be constructed in a substantial manner and properly maintained at the border of said highways, in such manner as not to interfere with public travel or the use of said highways.
