J. B. Gray, Chairman, presiding the following business was transacted.

Motion made by Commissioner Greer, seconded by Commissioner Gray, that the following affidavits of erroneous assessment filed and approved by Garrett Newman, County Assessor, be and the same are hereby approved, and the County Clerk is hereby authorized to issue certificates of error covering same. Upon roll call, both members voting in the affirmative, motion was by the Chairman declared carried.

Motion made by Commissioner Gray, seconded by Commissioner Greer, that the Board approve the Lease Agreement between Herd Equipment Company and the Board of County Commissioners, covering the rental of one 102 Galion Tandem Drive Diesel Motor Grader, Serial M.D. 8221, from February 26, 1947 up to the 31st day of June, 1947, at a rental of \$500.00 per month for the first months rental, and \$500.00 per month thereafter during the duration of this Lease Contract.
