

## O R D E R

WHEREAS, The Treasurer of Tulsa County, Oklahoma, has filed and presented to the Board of County Commissioners of the County of Tulsa, State of Oklahoma, an application for the issuance to G D KILLION of a deed conveying to him for a consideration of Ten & 44/100 (\$10.44) the following described lot, to-wit:

Lot 237, Tulsa Heights Addition to Tulsa.

AND, WHEREAS, The sale of said lot by the County Treasurer was made pursuant to Section 9745 of the Compiled Oklahoma for 1923, whereby the County Treasurer is authorized to sell lands and lots purchased for the County by him as tax re-sale, and

WHEREAS, due notice has been given and published by the County Treasurer in the Skiatook News, the official paper of the County of Tulsa, the said County Treasurer would on this date apply to the Board of County Commissioners for an order approving said sale and directing the issuance of deed therefor, and

WHEREAS, pursuant to such notice, hearing on such sale has been had by the Board of County Commissioners, and no other persons having appeared to bid a higher price for the purchase of said lot and the County of Tulsa has no need for said lot for any purpose whatsoever.

NOW, THEREFORE, The Board of County Commissioners of the County of Tulsa, of the State of Oklahoma, in regular session assembled and pursuant to the aforesaid statutes of Oklahoma, hereby approve the sale of said lot so made by the County Treasurer to G D KILLION for a consideration of the sum of \$10.44, and it is hereby ordered that the Chairman of the Board of County Commissioners execute to him a deed conveying to him all the right, title and interest of the County of Tulsa, of the State of Oklahoma, in and to said lot and the County Clerk of Tulsa County is hereby directed to attest his signature and attach thereto the seal of this office.
