WEDNESDAY, OCTOBER 25th, 1939.

G. H. Shepard, Chairman presiding, the following business was transacted.

Motion by Commissioner Sallee, seconded by Commissioner Shepard, that Miss Rose Johnson, be and she is hereby appointed head nurse at the Tulsa County Clinic as of November 1st, 1939, or when the clinic is started, at a salary of \$100.00 per month; <sup>Miss Johnson having been recommended by the Medical Society.</sup> Upon roll call, the following vote was taken: Shepard, Aye; Morley, Pass; Sallee, Aye. Motion carried.

Motion by Commissioner Sallee, seconded by Commissioner Shepard, that Dorothy Johnson, be and she is hereby appointed nurse at the Tulsa County Clinic as of November 1st, 1939, or when the clinic is started, at a salary of \$75.00 per month; <sup>Miss Johnson having been recommended by the Medical Society.</sup> Upon roll call, the following vote was taken: Shepard, Aye; Morley, Aye; Sallee, Aye. Motion carried.

Motion by Commissioner Morley, seconded by Commissioner Sallee, that Mrs. Be May Duncan, be and she is hereby appointed nurse at the Tulsa County Clinic as of November 1st, 1939, or when the clinic is started, at a salary of \$75.00 per month; <sup>Mrs. Duncan having been recommended by the Medical Society.</sup> Upon roll call, the following vote was taken: Shepard, Aye; Morley, Aye; Sallee, Aye. Motion carried.

Motion by Commissioner Morley, seconded by Commissioner Sallee, that the affidavit of erroneous assessment filed by John A. Souder and approved by Dan A. Rowe, County Assessor, covering real estate for the year 1939, be and the same is hereby approved and the County Clerk is hereby instructed to issue a certificate of error covering same. Upon roll call, the following vote was taken: Shepard, Aye; Morley, Aye; Sallee, Aye. Motion carried.

Motion by Commissioner Sallee, seconded by Commissioner Morley, that Cash Fund Estimate of Needs and Request for Appropriation for the County Erosion Cash Fund in the total sum of \$381.62, be and the same is hereby approved and the Chairman is authorized to sign said request and the same is hereby submitted to the Excise Board for their consideration. Upon roll call, the following vote was taken: Shepard, Aye; Morley, Aye; Sallee, Aye. Motion carried.
