Paving is to include the necessary fine grading, after general grading has been completed, and the contractor to whom is awarded the general grading shall construct the shoulders and ditches, strictly in accordance with the typical plans and cross sections. No other allowance will be made for grading except the general cross sectional quantities.

PAVING

We propose to pave with concrete according to Tulsa County Standard 1:2:3 Mixture (crushed Stone Coarse aggregate) Modified Bates Type 10"-7"-10" Thickness, Expansion Joints Fifty (50') feet apart, complete and in place,

We propose to pave with concrete Oklahoma Standard Plan, Bates Type, 1:2:3½ Mixture (Crushed Stone Coarse Aggregate) 9"-6"-9" Thickness, Expansion Joints Fifty (50') feet apart, complete and in place

Note: Gravel as Coarse aggregate may be used only when meeting the approval of the County Engineer

Force Account or Extra Work as may be ordered by the County Engineer, at cost, plus ten per cent (.10%) per cent.

If awarded a contract for the grading, we agree to complete all the general grading within thirty (30) working days from this date and to do all the shoulder work and cleaning up; restoring the ditches and shoulders to the typical plan and cross-sections within twenty one (21) days after the completion of the paving.

If awarded the contract for both paving and grading, we agree to complete all the said work within forty five (45) working days from this date and if awarded the contract for paving only, we agree to pave the said road, completing the same within thirty (30) working days from the completion of the general grading, and on failure to do so, we agree to pay Tulsa County, as acknowledged liquidated damages, the sum of \$25.00 per day for each day thereafter the work remains uncompleted.

Certified check amounting to \$3,000.00 being approximately 5% of the sum bid, is hereto attached, conforming to the requirements of the specifications.
