Pursuant to recess heretofore taken, the Board of County Commissioners reconvened at the hour of 10:00 O'clock A. M., with all members present: Claude W. Bailey, Chairman; Roy Evans and John Couch, Members. William P. Gable, Jr., County Clerk.

Claude W. Bailey, Chairman, presiding, the following official business was transacted:

Motion made by Commissioner Evans, seconded by Commissioner Bailey, and unanimously carried, that the following Payroll be, and the same is hereby approved for payment, and the County Clerk is hereby authorized to issue warrants covering same:

Motion made by Commissioner Evans, seconded by Commissioner Bailey, and unanimously carried that the following temporary employees in the office of the County Treasurer be, and the same are hereby approved:

Motion made by Commissioner Bailey, seconded by Commissioner Evans, and unanimously carried, that the Contract and Performance Bond of the L. & S. Construction Co. and the Board of County Commissioners, covering construction of a septic tank and disposal field at the W. T. Vernon Separate School, located in the Bixby School District No. 23, which Contract/<sup>and Bond</sup>are filed of record, be and the same are hereby approved and the Chairman is hereby authorized to execute same.

Motion made by Commissioner Evans, seconded by Commissioner Couch, and unanimously carried, that the following request of the County Treasurer is hereby approved, and the County Treasurer is hereby authorized to re-invest the money as set out in his request.

"An investment in Class "C" United States Bonds, of \$7,500.00, made in 1948, out of School District Sinking Funds available for that purpose, have matured. The interest earnings amount to \$2,500.00.

"Therefore, in accordance with Title 62, Section 541, Oklahoma 1941 Statutes, I desire authority to re-invest the sum of \$10,000.00 in United States Treasury Certificates Series "D". These fully mature within three years, but may be cashed, at par, plus accrued interest within Six months of the date of issue. These Certificates are well suited to this type of investment, and are wholly within statutory requirements. No immediate need requires this money. No commission is charged in the transaction."

Motion made by Commissioner Bailey, seconded by Commissioner Evans, and unanimously carried, that the matter of the flooding on the county road lying west of the pond in the Northwest corner of Section 31, Township 19, North, Range 14 East, be and the same is hereby referred to the County Attorney.
