

Motion made by Commissioner Couch, seconded by Commissioner Bailey, and unanimously carried, that the following Resolution be and the same is hereby adopted:

RESOLUTION

To authorize continued operation of airport spur track by City of Tulsa and releasing United States of American from obligation to restore surface of highway.

WHEREAS, on May 17, 1943 Tulsa County granted to the United States a licence to cross the public road between Sections 12 and 13, Township 20 North, Range 13 East by a railroad spur crossing, all as provided by the terms of a written contract of said date; and

WHEREAS, The city of Tulsa has acquired the said spur track and desires to continue to operate the same in connection with the Tulsa Municipal Airport.

NOW THEREFORE BE IT RESOLVED AS FOLLOWS:

1. That the United States of American be, and it is hereby released from any and all claims of Tulsa County arising under the said license contract of May 17, 1943, and especially from any obligation to restore the surface of the public highway therein mentioned.

2. BE IT FURTHER RESOLVED that the City of Tulsa be, and it is hereby, authorized to continue the operation of said spur track and that the Board of County Commissioners hereby license the continued use of same across the public highway all in accordance with a certain license in writing to become effective as of November 1, 1950.

a. That the bond be approved and the approval thereof be endorsed by the chairman of this board, and

b. That the petition and bond be received and filed and that hearing on said petition be had before this Board on the 27th day of November, 1950 at 10 o'clock A.M., and that the County Clerk be authorized and directed to give notice of said hearing as required by law, and publish it on two separate Thursdays in the Tulsa Daily World, a newspaper published and of general circulation in Tulsa County and in the territory of the proposed district.
