MONDAY, NOVEMBER 22, 1948

Pursuant to recess heretofore taken, the Board of County Commissioners reconvened at the hour of 10:00 O'clock A. M., with all members present: Claude W. Bailey, Chairman; Roy Evans and John Couch, Members. William P. Gable, Jr., County Clerk.

Claude W. Bailey, Chairman, presiding, the following official business was transacted:

Upon instruction of the Chairman of the Board of County Commissioners, the following sealed bids on the construction and erection of Booker T. Washington High School, Tulsa, Oklahoma, were opened:

Walco-De Witt Contractors, in the amount of \$1,486,500.00, together with Surety Bond made by the Standard Accident Insurance Company for ten percent of the amount of the bid; Tulsa Rig, Reel & Manufacturing Company, in the amount of \$1,532,850.00, together with Surety Bond made by the National Surety Corporation for ten percent of the amount of the bid; W. R. Grimshaw Co., in the amount of \$1,440,000.00, together with Surety Bond made by the Standard Accident Insurance Company for ten percent of the amount of the bid; D. C. Bass & Sons Construction Company, in the amount of \$1,559,957.00, together with bond made by the United States Fidelity and Guaranty Company for ten percent of the amount of the bid; Gross Construction Company in the amount of \$1,598,000.00, together with Bond made by Maryland Casualty Company, in the amount of \$170,000.00; Manhattan Construction Company, in the amount of \$1,441,300.00, together with Bond made by the Standard Accident Insurance Company for ten percent of the amount of the bid.

Motion made by Commissioner Evans, seconded by Commissioner Bailey, and unanimously carried, that the matter of the consideration of the bids be passed until 2:30 O'clock P. M.

Motion made by Commissioner Couch, seconded by Commissioner Bailey, and unanimously carried that the Cash Fund Estimate of Needs and Request for Appropriation for the County Highway Cash Fund, in the amount of \$16,778.46, and the Cash Fund Estimate of Needs and Request for Appropriation for the County Highway Restricted Cash Fund, in the amount of \$6,377.02, be and the same are hereby approved, and the Chairman is authorized to sign same and submit them to the Excise Board for their consideration.

Motion made by Commissioner Couch, seconded by Commissioner Bailey, and unanimously carried, that the increase of Miss Nelle Marion, Deputy in the office of the Court Clerk, from \$190.00 per month to \$225.00 per month for the months of November and December, 1948, be and the same is hereby approved.

Motion made by Commissioner Couch, seconded by Commissioner Bailey, and unanimously carried, that the following claims be and the same are hereby approved for payment and the County Clerk is hereby authorized to issue warrants covering same:
