The County Commissioners of Tulsa County met in County Clerk's Office Monday ^{May 3} 1909 at 9 A.M. Pursuant to previous agreement. In the matter of the Road Petition of L. E. Sturson on motion of Board the report of the viewers was accepted and the following damages were awarded. To Mary McTea One Hundred Dollars.

The resignation of E. P. Robertson as Clerk of Lynn Lane Township was read and same was accepted. W. B. Grimes was appointed Clerk of Lynn Lane Township versus E. P. Robertson resigned. The following resolution was ordered spread upon the records. That the County Clerk be instructed to request the State Examiner to check up the different offices of Tulsa County as soon as convenient. The Bond of W. L. Mayfield as Constable of Tulsa Township was on motion ^{approved} accepted. A clerical error being made in the assessment on lot 4 Block 5 Oakdale Addition amounting to \$7.88. Warrant was ordered drawn for the amount. The Quarterly Report of H. C. Walkley Register of Deeds was on motion accepted. The Commissioners adjourned to meet Tuesday May 4 1909 at 9 A.M.

The County Commissioners met in County Clerk's office Tuesday May 4 1909 at 9 A.M. Present W. L. North, C. H. Clelland & Geo. McTeahan. It being shown that The Texas Co. was on certain property assessed by the local assessors also by The State Board there for making a double assessment of \$83.27. On motion of Board the above amount was ordered stricken from the Tax Rolls. The Taxes on lot 7 Block 30 Tulsa were ordered stricken from the Tax Rolls as it is property of United Presbyterian Church. On motion A. H. Collins was appointed Highway Engineer.
