Ninety Dollars (\$90.00) per month on salary of Farm Demonstration Agent and they will also pay Ninety Dollars (\$90.00) on salary of Home Demonstration Agent, furnish them with franking privilege, stationery, literature and instructions. The Extension Division shall superintend the work of the agents and pay their expenses when duly authorized to make trips outside of the county on official business.

The Agents salary shall be payable on or after the first of each month on certificate from the extension Division of the A. & M. College that the work had been dupy performed.

This agreement shall be in force for the Farm Demonstration agent 12 months, beginning 1st day of July, 1921.

This agreement shall be in force for the Home Demonstration Agent 12 months, beginning 1st day of July, 1921.
