RESOLUTION PROVIDING FOR THE ISSUANCE OF NEGOTIABLE COUPON BONDS IN WATER IMPROVEMENT DISTRICT NO. 8, TULSA COUNTY, OKLAHOMA, IN THE AGGREGATE AMOUNT OF \$141,145.79, PRESCRIBING THE FORM OF SUCH BONDS, THE MATURITY DATES THEREOF, THE INTEREST RATE THEREON, THE MANNER OF PAYMENT, AND DECLARING AN EMERGENCY.

WHEREAS, on the 28th. day of May, 1929, a Resolution declaring assessments to pay the costs of water improvements in Water Improvement District No. 8, Tulsa County, Oklahoma, passed by the Board of County Commissioners of Tulsa County, Okla. was duly published as provided by law in Tulsa County, Oklahoma, said Resolution declaring total assessments in said District on account of said water improvements and the cost thereof in the sum of \$148,900.00, and

WHEREAS, there no remains unpaid on said assessments the principal sum of \$141,145.79, and

WHEREAS, more than thirty (30) days have expired since the date of the last publication of the assesssing Resolution, and the Board of Directors of Water Improvement District No. 8, Tulsa County, Oklahoma, has prepared and submitted this resolution providing for the issuance of negotiable coupon bonds in the aggregate amount of such assessments then remaining unpaid.

NOW, THEREFORE, BE IT RESOLVED, By the Board of County Commissioners of Tulsa County, Oklahoma:

SECTION 1. That there be issued negotiable coupon bonds of Water Improvement District No. 8, Tulsa County Oklahoma, in the aggregate principal amount of \$141,145.79, which said bonds shall be Series A, dated the 28th. day of May, 1929, and shall be numbered serially from One to Two Hundred and eighty three (283), both inclusive, Bonds numbered One (1) to Two Hundred Eighty Two (282) both inclusive, to be the principal denomination of Five Hundred Dollars (\$500.00) and Bonx No. (283) Two Hundred and Eighty three of the principal denomination of One Hundred Forty Five and 79/100 Dollars (\$145.79). All of such bonds shall mature and be payable on or before the 1st. day of October, 1948, and shall draw interest at the rate of six (6%) per cent per annum from the date thereof, payable October 1, 1929, and semiannually thereafter, on the first days of April and October of each succeeding year until paid. Said bonds shall have attached thereto interest coupons bearing facsimile signatures of the Chairman of the Board of County Commissioners and the County Clerk of Tulsa County, Oklahoma, and said bonds shall be executed and signed by the Chairman of the Board of County Commissioners and County Clerk of Tulsa County, Oklahoma, and sealed with the seal of said County. Said Bonds and interest coupons shall be payable at the fiscal agency of the State of Oklahoma, in the City of New York, State of New York, and shall be in the following form, to-wit:

KNOW ALL MEN BY THESE PRESENTS:

That Water Improvement District Number 8 of Tulsa County, State of Oklahoma, a municipal corporation for value received, hereby acknowledges itself indebted to and promises to pay to the bearer hereof, the sum of Five Hundred (\$500.00) Dollars on or before October 1st. 1948, with interest thereon from the date hereof at the rate of 6% per annum, payable October 1st. 1929 and semi annually thereafter on the 1st. days of April and October of each year until the maturity of this bond, as provided by law, as evidenced by and upon the surrender of the annexed interest coupons, as they severally become due, and with interest on said principal and delinquent interest, after maturity, and to payment date, at the rate of six (6%) per cent per annum. Both principal and interest are payable in lawful money of the United States of America, at the fiscal agency of the State of Oklahoma, in the City of New York, State of New York.

This Bond is one of a series of Water Improvement Bonds, numbered in numerical order, issued in the manner and form prescribed by law, pursuant to a resolution adopted by the Board of County Commissioners of Tulsa County, Oklahoma, and delivered for the purpose of paying the cost and expense of constructing a water distribution system within Water Improvement District No. 8, Tulsa County, Oklahoma, and is payable solely from assessments which have been regularly levied upon the lots, pieces and parcels of land benefitted by said water distribution system, and from the accumulation of interest and penalties arising from said assessments, which assessments, interest and penalties said Water Improvement District No. 8 of Tulsa County, Oklahoma, undertakes to collect as by law
