

It is further understood and agreed by and between the parties hereto that on all moneys so paid to the County Treasurer of Tulsa County, State of Oklahoma, party of the second part, if he has not been fully compensated prior to the payment of said moneys, must file his claim and substantiate the same by competent and proper proof, within 30 days from the date of such payment.

It is further understood and agreed that a copy of this contract presented by DAN TANKERSLEY, party of the second part, to any official, Board or Commission of the State of Oklahoma, shall be his full and complete authority to appear for and represent the said County of Tulsa, State of Oklahoma, in all matters covered by the terms hereof.

R E S O L U T I O N

BE IT REMEMBERED: That on this 26th. day of June, 1933, the Board of County Commissioners of Tulsa County, State of Oklahoma, assembled in adjourned regular session, was presented with the application for contract by one DAN TANKERSLEY, wherein the said DAN TANKERSLEY agreed to audit the gross production tax fund now held by the Oklahoma Tax Commission, and other tax collecting agencies, to substantiate the claim of Tulsa County to any part of said fund, as more fully set out in Senate Bill No. 420 relative to said fund, and the limitation for presentation of claims against said fund and the collection of moneys due therefrom, and

WHEREAS, the said DAN TANKERSLEY tendered a contract to the said Board of County Commissioners for their acceptance or adoption; and

WHEREAS, said contract was openly discussed by said Board; and

WHEREAS, said Board finds that the said contract is in all things fair, just and reasonable and to the best interests of the County, and that its adoption and ratification by this Board will, in all probability, result in large sums of money being saved for the County, which may otherwise within a short time be transferred into the General Fund of the State of Oklahoma, and placed beyond the reach of the County.

NOW, THEREFORE, BE IT RESOLVED, by the said Board of County Commissioners, that said Board of County Commissioners does hereby adopt and accept said contract and authorize the execution thereof, and the Chairman of the Board, be and he is hereby authorized to sign said Contract upon behalf of the Board, and the County Clerk is hereby ordered to attest said Contract with the seal of the County thereto affixed, as by law provided.

Upon motion of Commissioner North, and seconded by Commissioner Hedgecock, it was moved that the contract above referred to, and the resolution be and the same is hereby adopted.

All members voting in the affirmative, the Chairman declared the said Resolution adopted.
