FRIDAY, MAY 27, 1983

The Board of County Commissioners for Tulsa County, met at the hour of 10:00 a.m. with the following members present: Terry Young, Chairman; Melvin C. Rice, Member; Lewis Harris, Member; and Anita Nesbitt by Nancy Cooper, County Clerk.

Terry Young, Chairman, presiding called the meeting to order at 10:15 a.m. and the following business was transacted:

Motion made by Rice, seconded by Harris, to approve and authorize execution by Chairman, the Notice of Public Hearing on the proposed budget of Federal Revenue Sharing Funds for the Fiscal Year 1983-84 in the amount of \$2,200,000., with amendments discussed and subject to changes to be made at said public hearing; and approve publication of the Notice of Public Hearing before the Budget Board of the Tulsa County Budget for all funds.
