Now on this 3rd day of December 1917, came on to be heard the petition of Twelve freeholders living in the vicinity, to vacate a road on the section line between Sections 14 and 23 , Township \$9 North, range 12 East, in Tulsa County, Oklahoma, beginning at the Southwest corner of said Section 14 and the Northwest corner of said Section 23 and running thence East to the Arkansas River, and it appearing that said petition had been set down for hearing on this date, and that notice of such hearing had been published in the official county paper for at least twenty days as required by law, it is therefore ordered by the Board of County Commissioners of Tulsa County, Oklahoma, that said petition be denied as to the vacation of said road from the Southwest corner of said Section 14 and the Northwest corner of said section 23 then running East a quarter of a mile, and that the same be granted as to said road from a point a quarter of a mile East of N.W. and S.W of Sec. 23 and the S.W+ of Section 14.Twp 19 North.Range 12 East, and that said road be and the same is hereby vacated from a point a quarter of a mile East from the Southwest corner of said Section 14 and the Northwest corner of said Section 23 and thence East to the Arkansas River.

RESOLUTION

WHEREAS, under date of February 8th 1916, the Board of County Commissioners of Tulsa County.Oklahoma, entered into a written agreement with one Arthur C.Farmer of Tulsa,Oklahoma, by the terms of which the said Arthur C.Farmer was employed for the purpose of compiling new indexes of certain records therein mentioned and whereby it was agreed that the said Farmer should employ an assistant in connection with the said work, at a monthly salary of One Hundred Dollars (\$100.00) per month, to be paid by the Board of County Commissioners during the time said work was being completed, and

WHEREAS, said essistant has been employed & a monthly salary of One Hundred Dollars \$100.00) per month and it has been found that the same is not an adequate salary considering the character and amount of work being done, and that the said salary should be increased to the sem of One Hundred Twenty-five Dollars (\$125.00) per month, and which said salary was, by the Board, informally increased to One Hundred Twenty-five Dollars \$125.00) per month. commencing with the month of November, 1917.

NOW, THEREFORE, for the purpose of formally evidencing the action of the Board in increasing the said salary, a above mentioned, Be It Resolved: That said salary for said assistant be and the same is hereby increased and fixed at the sum of One
