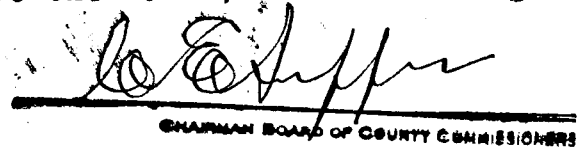


Hundred Twenty-five dollars, \$125.00) per month , commencing with the month of November, 1917.
