The section line road known as East 61st Street, beginning at the NE. Cor. of Sec. 1, T18N, R14E, and extending west of the eastern meander line of the Arkansas River;

The section line road known as East 71st Street, beginning at the NE. Cor. of Sec. 11, TISN, RIJE, and extending west to the NW. Cor. of Sec. 7, TISN, RIJE; also, the section line road along the south sides of Sections 1 and 2, TISN, RIJE;

The section line road known as East Slst Street, beginning at the western city limits of the Town of Broken Arrow, Oklahoma, and extending west to the eastern meander line of the Arkansas River; also from the city limits of the Town of Broken Arrow, Oklahoma, east along the south sides of Sections 11, and 12, TISN, R14E, to the Tulsa-Wagoner County line;

The section line road beginning at the NE. Cor. of Sec. 24, T18N, R14E, and extending west to the eatern meander line of the Arkansas River;

The section line road beginning at the NE. Cor. of Sec. 29, TISN, RI4E, and extending west to the eastern meander line of the Arkansas River;

The section line road beginning at the NE. Cor. of Sec. 32, TIEN, R14E, and extending west along the north sides of Sec. 31 and 32, TIEN, R14E,; and, beginning at the NE. Cor. of Sec. 35, TIEN, R13E, and extending west to the eastern meander line of the Arkansas River;

The section line road beginning at the northeast Cor. of Sec. 7, T17N, R14E, and extending west to the eastern meander line of the A_r kansas River;

The section line road beginning at the NE. Cor. of Sec. 15, T17N, R14E, and extending west to the eastern meander line of the Arkansas River;

The section line road known as West 21st Street, beginning at the NE. Cor. of Sec. 15, T19N, R12E, and extending west to the meander line of the Arkasnas River;

The section line road known as West 41st Street, beginning at the city limits of Tulsa, Oklahoma, and extending west to forks in the road approximately # mile east of the NW. Cor. of Sec. 30, T19N, R12E;

The section line road known as West 31st Street, beginning at the city limits of Tulsa, Oklahoma, and extending east to the western meander line of the Arkansas River;

The half section line known as the Garden City road beginning at the city limits of Tulsa, Oklahoma, and extending thru the center of Sect 23, T19N, R12E, to the western meander line of the Arkansas River;
