The section line road known as West 51st Street, beginning at the southwest cor. of Sec. 29, T19N, R12E, and extending east to the city limits of Tulsa, Oklahoma; also from the city limits of Tulsa, Oklahoma, east along the north sides of Sections 34, 35 and 36, T19N, R12E, to the western meander line of the Arkansas River;

The road beginning approximately $\frac{3}{4}$ mi. north of the SW. Cor. of Sec. 18, T19N, R12E, and extending south approximately $1\frac{1}{4}$ Mi. thence southeasterly to join the forks of West 41st Street approximately $\frac{1}{4}$ Mi. east of the SW. Cor. of Sec. 19, T19N, R12E;

The section line road beginning at the NE. Cor. of Sec. 18, T19N, R12E, and extending south along the east sides of Sections 18 and 19, T19N, R12E;

The section line road beginning at the NE. Cor. of Sec. 17, T19N, R12E, and extending south to the Tulsa-Creek County line;

The section line road along the east side of Sec. 16, T19N, R12E;

The section line road known as 33rd, West Avenue, beginning at the city limits of Tulsa, Oklahoma, and extending south to the Tulsa-Creek County line;

The section line road known as South Union Avenue, beginning at the southern city limits of Tulsa, Oklahoma, and extending south to the NE. Cor. of Sec. 3, T18N, R12E;

The section line road known as South Elwood Avenue, beginning at the half section line $\frac{1}{2}$ mile north of the NE. Cor. of Sec. 26, T19N, R12E, and extending south to the NE. Cor. of Sec. 2, T18N, R12E;

All in Tulsa County, State of Oklahoma, and in accordance with the attached map marked "Exhibit A".
