Claude W. Bailey, Chairman, presiding, the following official business was transacted:

Motion made by Commissioner Evans, seconded by Commissioner Couch, and unanimously carried, that upon the recommendation of the County Attorney, the Contract of the Grimshaw & Sons Construction Company on the construction of the Booker T. Washington High School, be approved, and that the Chairman be authorized to execute the same, and that the delivery of the contract be deferred until such time as the contractors shall furnish the required surety bonds and insurance certificates.

Thereafter, and after many of the interested parties had left the meeting, the Board gave further consideration to the action taken by this Board with reference to Water Improvement District No. 16, and after Hugh Webster, W. L. Eagleton and R. R. Linker had further discussed these proceedings and the apportionment of costs, Couch moved that this Board rescind its action this day taken "that we set aside Water Improvement District No. 16." Motion was seconded by Bailey and on roll call, the vote was:

M., in the County Commissioners' Room in the County Court House in Tulsa, Oklahoma, for the purpose of hearing any further complaints or objections that may be made concerning said appraisalment and apportionment as to any such tracts, lots and parcels of land and that notice of such session and hearing shall be published by the County Clerk for two weeks in the Tulsa Daily World.

Motion made by Commissioner Evans, seconded by Commissioner Couch, and unanimously carried, that the following claims be and the same are hereby approved for payment and the County Clerk is hereby authorized to issue warrants covering same:
