whereas, this declaration of policy is but in keeping with good business and is the aim of this Board of County Commissioners to give to the citizenship of Tulsa County a strictly business administration in the donduct of such transactions as may properly come Wefore these Board of County Commissioners, and

WHEREAS, it is the desire and wish of this board to have the co-operation and support of the splendid citizenship of this county, and in appreciation of the editorial as set out above, which in truth and fact the editorial and the quotation properly bespeaks what should be the aim of all public officials,

NOW, THEREOFRE, BE IT RESOLVED, that this Board pledge itself to these principles and aims, that they endeabour to give to Tulsa County a clean business administration and a strict accounting therefor, and order that this resolution be inserted in the minutes of the meeting of this Board and a copyulof the same furnished to Thomas Latta, in appreciation of his support and approval.

All members present voting in favor of the resolution, the same was by the chairman declared carried.

Moved by F. M. Wooden and seconded by G. E. Gilmore, that the matter of the placing of fruit trees on the county farm be referred to the County Farm Demonstrator for consideration, making report to this Board of the kind and best varatees suitable best therefor. Motion carried.

A motion was made by F. M. Wooden and seconded by G. E. Gilmore that the County Superintendent, Minnette Hedges, be instructed to comfer with MaMie Harrison with reference to the purchasing of an acre tract of land in School District No. 69 for separate School Purposes, and in the event a satisfactory agreement can not be made, then the said County Superintendent is hereby instructed to take the matter up with the County Attorney, and start condemnation proceedings. The said motion receiving all of the votes of the said Board, the same was by the chairman, declared carried.

A motion was made by F. M. Wooden and sedonded by Ira Short that M. C. alternate

Cross, architect, be instructed to advertixe for/bids for the colored ward of the Tulsa

County Poor Farm, both for concrete block floor or pine floor with tile bath floor.

The vote on said motion being as follows: F. M. Wooden, Aye; Ira Short Aye, F. E. Gilmore, "Aye; all members having toted in the affirmative, the same was by the chairman declared carried.

Moved by F. M. Wooden and seconded by Ira Short that M. C. Cross, architect be authorized to prepare plans and specifications for the repairing and renewing water pipes and plumbing system of the Tulsa County Court House, and also advertise for bids therefor. Motion carried.

A motion was made by F. M. Wooden and seconded by G. E. Gilmore that Mrs. E. M. Hundley, Superintendent of the County Home, and Ira Short be authorized to purchase the furniture and new equipment for the Tulsa County Home. Motion carried.

A motion was made by F. M. Wooden and seconded by G. E. Gilmore that I Ira Short be the member of the Board of County Commassioners to serve as a member of the County Excise Board. Said motion unanimously carried.

A motion was made by F. M. Wooden and seconded by Ira Short, that the resolution former/of this Board made on the 8th day of July, 1921, in regard to the audit of John D. Porter Court Clerk, Broken Arrow Division, be and the same is hereby recinded. Motion prevailed.
