Motion was made by Commissioner North, seconded by Commissioner Hedgecock, that the appeal from the decision of the County Superintendent of Schools in the matter of the dissolution of School District No. 9 of Tulsa County, and the annexation of the territory comprising said District to Independent School District No. 22 and 27 was taken up and ordered continued to Ten (10:00) o'clock A M Wednesday, September 12th. 1928 at 10 o'clock A M.

Motion was made by Commissioner North, seconded by Commissioner Hedgecock that the County Clerk be and he is hereby instructed to spread an assessment of One Thousand(\$1,000.) Dollars on Tax Rolls for Perryman Drainage District. Such action was taken upon the recommendation of Drainage Commissioner B S Smedley. Carried.

The following Resolution was introduced by Commissioner North, who moved its adoption, and the motion to adopt was seconded by Commissioner Hedgecock, and the Chairman ordered the Resolution read:
