

TUESDAY, JULY 19th, 1921.

Pursuant to adjournment the Board of County Commissioners met in the office of the County Clerk at the hour of ten (10) o'clock P. M. of the above date, and upon roll call the following members were found to be present:

The secretary presented the following request of Wayne L. Dickey, County Treas.

A motion was made by F. M. Wooden and seconded by Ira Short that the County Clerk be authorized and instructed to advertise for bids on the Dunbar School Property in accordance with the report of the viewers. All members voting in favor of the motion, the same was by the chairman declared carried.

A motion was made by F. M. Wooden and seconded by Geo. E. Gilmore that Ira Short be authorized to sell the salvage on the Dunbar School Property in accordance with the report of the appraisers. Motion prevailed.

The bond of the First National Bank of Skiatook made by the Massachusetts Bonding and Insurance Company in the amount of \$7500.00, dated July 5th, 1921, is hereby approved by this Board of County Commissioners upon motion of F. M. Wooden duly seconded by Ira Short.

A motion was made by F. M. Wooden and seconded by Ira Short that the claim for damage submitted by W. C. Frost be and the same is hereby disallowed. Motion carried.

A motion was made by F. M. Wooden and seconded by Geo. E. Gilmore that the matter of the American National Bank, defunct, be referred to the County Attorney for the proper legal action to collect the amount of taxes due as disclosed by the County Treasurers tax rolls. Motion carried.
