The Commissioners then took up the proposition of purchasing the Toll Bridge across the Arkansas River, after considering reports by the County Bridge Engineer R. M. Hughes on condition of said Bridge and estimates of what a new bridge of like pattern would cost.

The County Commissioners there upon made an offer to the representatives of the Bridge Company in writing to the amount of \$21500⁰⁰. Warrants to be drawn after the next regular levy was made. Tulsa County to take immediate possession of same and declare it a free and open Bridge to the public. On acceptance of the above offer by the Bridge Company through their officers Geo J. Williamson and M. B. Paul the County Commissioners ordered the minutes of the meeting spread on the records of the Commissioners Proceedings.

Commissioners adjourned to meet Thursday June 10 '1909 at 9 A. M.

The Commissioners met June 10 '1909 at 9 A. M. Present W. L. North & C. H. Cleveland. On motion of Board Ben Brooks was appointed custodian of Bridge across Arkansas River to have charge of all tools, repairs and material and employ extra help in case of emergency.
