R E S O L U T I O N

NOW, THEREFORE, BE IT RESOLVED: That the said names parties, to-wit: Floyd V. Freeman, M A Dixon, Chas Brown and Harry Hamilton heretofore elected (or appointed) as Justices of the Peace in and for said District Four for the term expiring January 5th. 1931 be, and they are hereby notified and directed in compliance with the laws of the State of Oklahoma, and in particular Section 3435 C O S 1921, to deposit with their successor A M Kirkpatrick, their official dockets, as well as the dockets of their predecessors which may be in their custody, together with all files and papers, laws and statutes pertaining to their office, there to be kept as public records and property, or in lieu thereof to deposit same with the County Clerk of Tulsa County, Oklahoma.

BE IT FURTHER RESOLVED, that the County Clerk immediately serve a copy of this Resolution on each of the above named parties, and that they, and each of them take due notice thereof, under penalty of law.

WHEREAS, the Treasurer of Tulsa County, Oklahoma, has filed and presented to the Board of County Commissioners of the County of Tulsa, State of Oklahoma, an application for the issuance to JOHN HENDRIX of a deed conveying to him for a consideration of Forty Three and 56/100 the following described Land:
