

The following sealed bids were ordered opened by Mr. Bailey, Acting-Chairman, on the following described County owned property, - 1-1947 V-8 Ford 1½ ton truck, No. 799-T-1389661: N. L. Woodrow - \$125.00; Charles Samuels, 135.00 and L. Stockton's bid of \$155.00/ Mr. Stockton being the highest Bidder, motion was made by Commissioner Couch, seconded by Commissioner Bailey and carried, that this truck be sold to him.

Motion made by Commissioner Couch, seconded by Commissioner Bailey, and unanimously carried, that the Abstractor's Bond filed by the Oklahoma Abstract Company in the amount of \$5,000 and made by the National Surety Company, be, and the same is hereby approved and accepted.

Motion made by Commissioner Couch, seconded by Commissioner Bailey and unanimously carried, that the Cash Fund Estimate of Needs and Requests for Appropriation for 3-T Restricted Cash Fund in the amount of \$6,401.86, and for 4-T Restricted Cash Fund in the amount of \$9,444.15, be and the same are hereby approved and the Chairman is authorized to sign same and submit them to the Excise Board for consideration.

Motion made by Commissioner Bailey seconded by Commissioner Couch, and unanimously carried that the following Resolution be, and the same is hereby adopted:

RESOLUTION

BE IT RESOLVED that the Board of County Commissioners of Tulsa County, pursuant to Petition of affected property owners, does hereby relinquish all right, title or interest in the said County of Tulsa, Oklahoma, may have acquired by virtue of a certain Dedication of Street as contained in Plat to River Grove Subdivision, Tulsa County, Oklahoma, being Plat No. 773, filed of record in the office of the County Clerk of Tulsa County, on the 20th day of February, 1926, insofar as said Dedication covers the following described real estate situate in Tulsa County, Oklahoma, to wit:

That portion of the street lying North of Block 3 of said subdivision, that lies West of the extension of the west boundary line of the street lying between Blocks 1 and 2 of said subdivision, being a strip of land 50 feet wide and approximately 181.3 feet long along the Northside thereof, and extending to the Arkansas River, according to the recorded plat of said subdivision, and situated in Section 7, Township 18 North, Range 13 East, Tulsa County, Oklahoma,

which said tract of land has never been used, opened or accepted by Tulsa County for street or road purposes and is not needed or required by the County for said purpose.

BE IT FURTHER RESOLVED that the Chairman be, and he is hereby authorized and directed to execute and acknowledge this relinquishment in order that it may be recorded in the Deed Records in the office of the County Clerk of said County.
