ORDER THAT WAS OMITTED FROM MEETING OF JANUARY 26TH.1931.

IN THE MATTER OF AN UNDERGROUND SEWER LINE NOW CINSTALLED AND IN OPERATION THROUGH AND ACROSS CERTAIN PUBLIC HIGH-WAYS.

ORDER

NOW, On this 26th. day of January, 1931, the matter of the Petition of LUTHER B GRUBB, and his successors in interest, for a permanent right at all times, to have the full use and enjoyment, and the right to repair and maintain the hereinafter described sewer line now installed and in operation through and across certain public highways, came up before the Board of County Commissioners of said County for hearing; and it appearing to the Board, and each of the Commissioners thereof, that it was just and proper that said Petitioner should be granted the rights prayed for in his said petition.

IT IS HEREBY ORDERED by the Board of County Commissoners of Tulsa County, Oklahoma that said Luther B Grubb, and his successors in interest, is hereby granted a permanent right at all times to have the full use and enjoyment of, and the right to repair and maintain, the sewer line described as follows, to-wit:

Beginning at a point on the South Boundary Line of East 37th. Street 456 feet West of the West Boundary Line of Madison Street, thence in a diagonal Northwest direction 15 feettofat concrete manhole cover, thence West 452 feet parallel to and 12 feet North of said South Boundary line of East 37th. Street, and thence West with a slight deviation in direction to the South 187 feet, terminating In the Bed of the Arkansas River.

and located on the following described highway, to-wit:

A tract of land situated in the South Half of Lot Five (5) in Section Twenty Four, Township Nineteen North, Range Twelve, East (24-19-12) of the Indian Base and Meridian in Tulsa County, Oklahoma, and more particularly described as follows, to-wit: Beginning at a point Twenty Five (25) feet South and Twenty Five (25) deet West of the Northeast corner of the South Half of said Lot Five, said point being six hundred and thirty six and seventy-five hundredths (636.75) feet North of the Southbline of said lot Five, and running thence in a western direction and parallel to the North line of Lot Five, a distance of Ni e Hundred and twenty (920) feet, more or less, to a point on the high bank of the Arkansas River; thence in a Northwestern direction and on the high bank of the Arkansas River a distance of ten and eight tenths (10.5) feet, more or less, to a point sixteen and five tenths (16.5) feet south of the North Line of the South Half of Lot five (5), thence in an Eastern direction and parallel to the North Line of Lot Five (5) a distance of Nine Hundred and twenty Five (925.0) feet to a point sixteen and five tenths (16.5) feet South and twenty five Feet West of the Northeast corner of the South Half of Lot Five; thence in a Southern Direction and parallel to the East line of Lot Five; thence in a Southern Direction and parallel to the East line of Lot Five(5) a distance of Eight and five tenths (5.5) feet toothe point of beginning.
