buildings and facilities and levy and collect an annual tax in said County for the payment of the interest on and principal of said bonds, and the levy and collection of an additional ad valorem tax of one mill on the dollar of the assessed valuation of all taxable property in the County for the purpose of establishing and maintaining or aiding in establishing and maintaining public libraries and library services for fiscal year 1989/90 and each fiscal year thereafter until the Authority therefore shall be repealed by the registered qualified voters of Tulsa County at an election called upon the question of such repeal.
