Pursuant to a recess heretofore taken, the Board of County Commissioners reconvened at the hour of 11:00 o'clock a. m. with all members present: J. W. Hardesty, Chairman; John Couch and Claude W. Bailey, Members; Andy Stokes, County Clerk.

J. W. Hardesty, Chairman, presiding, the following business was transacted.

Motion made by Commissioner Couch, seconded by Commissioner Bailey, and unanimously carried, that the following Resolution be, and the same is hereby adopted:

RESOLUTION RELATING TO FEDERAL
OLD AGE AND SURVIVORS INSURANCE

The undersigned Board of County Commissioners of Tulsa County, State of Oklahoma, being in lawful session assembled on the day and date hereinafter inscribed, in the regular order of business properly presented, find that:

WHEREAS, Public Law 734, 81st Congress, authorizes the Social Security Administration, at the request of any State, to enter into an agreement with such State for the purpose of extending the benefits of the Old-Age and Survivors Insurance system established by Title II of the Social Security Act, to employees of such State or any political subdivision thereof; and

WHEREAS, we are advised that, pursuant to authority of Title 56, Chap. 7, Pg. 375, O.S.L. 1949, and Art. XXV of the Oklahoma Constitution, the State of Oklahoma, acting by and through its Department of Public Welfare, proposes to request said Social Security Administrator to enter into an agreement with the State of Oklahoma for the purpose of extending the benefits provided by said Title II to its employees and to those of its political subdivisions; and that it is further proposed to make said agreement effective on January 1, 1951; and

WHEREAS, it is deemed necessary, in order to insure the greatest benefits of said insurance system to the officers and employees of this county, that

WHEREAS, this board is desirous of securing the benefits accorded by said insurance system for the officers and employees of this county; and, in order to insure the fullest benefits thereof, it is deemed necessary that this county enter into an agreement with said Department of Public Welfare in time to permit said insurance system to be put in operation and become effective on January 1, 1951 :

THEREFORE BE IT RESOLVED:-

1. That this County, by and through its lawfully constituted Board of County Commissioners, does hereby adopt the terms, conditions, requirements, reservations, benefits, privileges, and other conditions thereunto appertaining, of Title II of the Social Security Act as amended by Public Law No. 734, 81st Congress, for and on behalf of all the officers and employees thereof and of its departments and agencies, save and except any of such officers and employees now covered or authorized to be covered by any retirement system provided by law for any employee or official of the county or any of its departments or agencies, and further excepting any official or employee whose compensation is on a fee basis or who occupies any position, office, or employment not authorized to be covered by applicable State or Federal laws or regulations;

2. That there shall be withheld from any salary or compensation due any such officer or employee not excepted as aforesaid whose compensation qualifies him or her to participation therein the percentage of salary, wage, or compensation required to be withheld by said Act, whether such compensation be computed in cash, quarters, subsistence, or in kind, and reserved in the treasury for quarterly remittance to the Oklahoma Public Welfare Commission quarterly as provided by law;

3. That, under this resolution, there is hereby required, and henceforth at the times and in the manner provided by law required, that there be made regularly an appropriation (or appropriations) from funds available to be appropriated for salaries, wages and/or personal compensation from general and/or special funds derived from ad valorem or other sources, sums sufficient to pay promptly, at the time and in the manner provided by law, the tax imposed on the county as employer under
