BE IT FURTHER RESOLVED, That the compensation of the said C E Marshall and W H Walker, as Tax Ferrets, be and the same is hereby fixed at fifteen (15%) per cent of any and all sums recovered by them as taxes on omitted property and actually paid to and received by the County Treasurer of Tulsa County. All claims for services rendered and compensation under this contract shall be presented to the Board of County Commissioners for allowance.

BE IT FURTHER RESOLVED, that a copy of this Resolution signed by the Board of County Commissioners, and by said C E Marshall and W H Walker shall constitute the contract of the employ as Tax Ferrets.
